Product description

Class A-60 Aluminium Bulkhead with 'SeaRox FB 6050' or 'SeaRox FM 6050',

Composed of structural aluminium bulkhead insulated on both sides with one layer of 70 mm or 75 mm thick mineral wool of type 'SeaRox FB 6050' or 'SeaRox FM 6050' (manufactured by Rockwool with nominal density 70 kg/m³). On the stiffened side the insulation material is installed between and around the stiffeners. The cavity of the stiffeners is fully filled out with the same insulation material.

The insulation is held in place using 3 mm steel pins (ALU tipped) with Ø38 mm steel washers welded with a c/c 300 mm in both longitudinal as transversal direction.

Alternatively, the insulation material and stiffener design (ref. SOLAS II-2/9.3.4) may be in accordance with drawing no. 1000-1 as listed below.

Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.

General application: Fire against either side

The insulation materials and adhesives used have to be approved according to the Marine Equipment Regulations and bear the UK Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
